The EMD should be deposited along with quotation in "**Demand Draft**" from any Nationalized Bank in favour of the **Director of Research**, Govt. of Arunachal Pradesh, SBI, Itanagar. The earnest money should be accompanied with quotation failing which the tender shall be liable to rejection.

The estimated cost of work is **Rs. 15.00 lakhs (Rupees fifteen lakhs)** only subject to the availability of fund in CFY under BE 2022-23.
